### 1.1. Justification About the Data Controller

Your personal data may be processed by EGEROBOT within the scope of KVK Law No. 6698. Within the scope of the law, EGEROBOT is accepted as the data controller.

### 1.2. Regarding Visitor Data

As the data controller within the scope of KVK Law No. 6698, the Company collects personal data directly from data owners verbally or physically and processes this personal data. You can access the table below regarding which personal data are collected and processed and how they are collected.

The personal data of all visitors who come to the workplace where EGEROBOT operates, for whatever reason, is requested and processed in order to ensure the security of the workplace where EGEROBOT operates and to fulfill its obligations under the Law No. 5188 on Private Security Services and relevant legislation. The personal data in question; It is obtained through identity information, HES code information, employment information, technical information, contact information, visual data and license plate information and security camera image methods.
